

But I over reacted in trying, as I thought, to "put things right"....

This model of ministry is most familiar to us all in the ministry of a chaplain for hospitals, nursing homes, etc. I have also filled this role in church congregations for a single Sunday or for a very short defined time. In these circumstances it is clear to everyone that the priest is not thought of as a member or leader of the congregation.

But when the ministry continues over a long period of time (4½ years to date), and members of the congregation insist from the beginning that "You are our priest, Mth. Ellen"..when I am repeatly asked "Mth. Ellen, what do you think?"....when the congregation insists that they pay my expenses to convention as their ordained delegate...when I am asked to sign the yearly parochial report....when my name is listed as the priest for Grace Church, Madison, in the Church Directory....I admit that I lost sight of the restricted nature of "supply priest."



I have spent time with Bishop John Tarrant and The Rev. David Hussey in several meetings, during the past ten days and I have poured out my lament of confusion over the pain that has been expressed by members of the congregation and that I am feeling myself. They have helped to clarify the issues for me in this long term

relationship. The most important learning point for me is the realization that the congregation and I both needed a Letter of Agreement...for me personally, A Job Description...so that all concerned would not so easily breach the boundaries of a mutually agreed upon relationship.

Bishop John and Father David have offered their help to the congregation in moving forward. Bishop John has also expressed his concern over the obvious condition of the church's building and the burden you are trying to shoulder. Bishop John and Father David are hoping to meet with the congregation within the next two months. That meeting will have to be during the middle of the week because of the Bishop's schedule. Until that time, I will attempt to fulfill the ministry of a "supply priest" for this congregation.

I ask you to help me remain mindful of the restricted nature of that ministry by not asking me (1) for guidance regarding your on-going housekeeping of the church and (2) matters concerning the ministry of this congregation.

And finally,  $4\frac{1}{2}$  years ago, when I observed the struggles some were having in completing the housekeeping chores, I suggested that you lighten those housekeeping labors by adopting the concept of a permanent dossel. In the same spirit of concern over your labors, I offered to take responsibility for the laundring of the Eucharistic altar linens. I return those linens and that responsibility to you now.

If this whole matter seems wrenching to the spirit and confusing to your understanding, I would ask you to be assured that God is in this. He is with us and for us.


